**NOTICE OF RELEASE
OF SECURITY INTEREST IN TRADEMARKS**

This **NOTICE OF RELEASE OF SECURITY INTEREST IN TRADEMARKS** ("Notice of Release"), effective as of September 21, 2018, is made by **CITIZENS BANK**, a Delaware state chartered bank, ("Administrative Agent"). Unless otherwise expressly indicated, all capitalized terms used, but not defined, in this Notice of Release have the meanings indicated in the Trademark Security Agreement (as defined below).

WHEREAS, CROWLEY CHEMICAL COMPANY, INC., a New York corporation, ("Grantor"), made that certain Trademark Security Agreement, effective as of January 8, 2007, which was recorded in the records of the United States Patent and Trademark Office ("USPTO") on February 23, 2007 at Reel 003487, Frame 0685, whereby Grantor granted to Administrative Agent, for the benefit of the Secured Parties, a continuing security interest in all of such Grantor's right, title and interest in, to and under the Trademark Collateral, including, without limitation, each trademark listed on Schedule A, attached hereto; and

WHEREAS, Administrative Agent has agreed to release the Trademark Security Agreement and the security interests and liens on the Trademark Collateral granted to Administrative Agent pursuant thereto.

NOW, THEREFORE, Administrative Agent hereby agrees as follows:

1. **Release of Security Interest.** For valuable consideration, Administrative Agent hereby terminates, discharges and releases the Trademark Security Agreement and any and all mortgages, liens and security interests in the Trademark Collateral granted to Administrative Agent pursuant to the Trademark Security Agreement, in each case without representation, warranty or recourse of any kind, and any right, title or interest of Administrative Agent in such Trademark Collateral pursuant to the Trademark Security Agreement shall hereby cease and become void.


2. **Authorization.** Administrative Agent authorizes this Notice of Release to be recorded with the USPTO.
