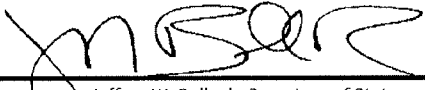

Pursuant to Section 264 of the General Corporation Law of the State of Delaware and
Section 18-209 of the Delaware Limited Liability Company Act

Sesame Acquisition Merger LLC, a Delaware limited liability company (the "LLC"), does hereby certify as follows:

FIRST: The LLC is a Delaware limited liability company duly formed and existing under the laws of the State of Delaware and Slideshare, Inc., a Delaware corporation (the "Company"), is a corporation duly organized and existing under the laws of the State of Delaware.

SECOND: The Agreement and Plan of Merger, dated as of May 3, 2012, as amended by Amendment No. 1 thereto, dated as of May 17, 2012, by and among the Company, LinkedIn Corporation, a Delaware corporation ("LinkedIn"), Sesame Acquisition Merger Corporation, a Delaware corporation ("Sesame"), the LLC and certain other parties set forth therein (the "Merger Agreement"), setting forth the terms and conditions of the merger of the Company with and into the LLC (the "Merger"), been approved, adopted, certified, executed and acknowledged by the LLC and the Company in accordance with Section 264(c) (and with respect to the Company, by written consent of its sole stockholder in accordance with Section 228) of the General Corporation Law of the State of Delaware and Section 18-209 of the Delaware Limited Liability Company Act.

THIRD: The name of the surviving limited liability company in the Merger (the "Surviving LLC") is Sesame Acquisition Merger LLC, which name shall be amended as set forth in Article Fourth below.

FOURTH: The Certificate of Formation of the LLC as in effect immediately prior to the Merger shall be amended by deleting Section I thereto and replacing it in its entirety with the following:

"1. The name of the limited liability company formed is Slideshare LLC."

FIFTH: The executed Merger Agreement is on file at the principal place of business and office of the Surviving LLC at the following address:

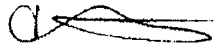
