**RELEASE OF SECURITY INTEREST
IN CERTAIN TRADEMARK COLLATERAL**

This RELEASE OF SECURITY INTEREST IN CERTAIN TRADEMARK COLLATERAL, dated as of September 25, 2018 (this "Release"), is made by **SJC DLF II-E, LLC**, in its capacity as agent for the Secured Parties (in such capacity, the "Agent"), in favor of **AMERICAN CIVIL CONSTRUCTORS HOLDINGS, INC.** ("American Civil") and **SAIIA CONSTRUCTION COMPANY LLC** ("Saiia"). Each of American Civil and Saiia is referred to herein individually as a "Grantor", and collectively, the "Grantors". Capitalized terms used in this Release and not otherwise defined herein have the meanings specified in the Intellectual Property Security Agreement (as defined below).

WITNESSETH

WHEREAS, pursuant to the Intellectual Property Security Agreement, dated as of January 27, 2015 (as amended, amended and restated, supplemented or otherwise modified prior to the date hereof, the "Intellectual Property Security Agreement"), and recorded with the U.S. Patent and Trademark Office on January 27, 2015, at Reel/Frame No. 5447/0465 (with respect to American Civil) and Reel/Frame No. 5447/0449 (with respect to Saiia), each Grantor granted to the Agent a Lien on and continuing security interest in all of such Grantor's right, title and interest in and to the following collateral, whether then owned or thereafter acquired, but excluding any Intellectual Property for which the granting of a security interest therein would terminate, invalidate, void, cancel, degrade or abandon such Intellectual Property: (i) the U.S., state and foreign trademark and service mark registrations, and trademark and service mark applications, set forth on Schedule A attached hereto, including, without limitation, all common-law rights related to, and all goodwill of the business associated with the foregoing, (ii) any and all claims and causes of action for past, present or future infringement of any of the foregoing, with the right, but not the obligation, to sue for and collect damages for infringement of the foregoing, (iii) any and all licenses or rights granted under any of the foregoing, and all license fees and royalties arising from such licenses or rights, in each case to the extent permitted by such licenses or rights, (iv) any and all amendments, renewals, extensions, reissuances and replacements of any of the foregoing, and (v) and all products and proceeds of any of the foregoing (with respect to such Grantor, its "Released Registered Trademarks"); and

WHEREAS, each Grantor has requested that the Agent release its Lien on and continuing security interest in all right, title and interest of such Grantor in, to and under such Grantor's Released Registered Trademarks; and

WHEREAS, the Agent now desires to terminate and release its Lien on and continuing security interest in all right, title and interest of each Grantor in, to and under such Grantor's Released Registered Trademarks), and to reassign any all rights, title and interest in the same to such Grantor, in each case, as provided in this Release.

NOW, THEREFORE, the Agent, without recourse, representation, warranty, promise, undertaking, statement or assurance of any kind or nature, and at the Grantors' sole cost and expense, hereby terminates, cancels and releases its Lien on and continuing security interest in


all right, title and interest of each Grantor in, to and under such Grantor's Trademarks Released Registered Trademarks, and hereby reassigns to such Grantor any right, title and interest it may have in such Grantor's Released Registered Trademarks to such Grantor.

The Agent authorizes and requests that the Commissioner of Patents and Trademarks and any other applicable government officer record this Release at the Grantors' sole cost and expense.
