RELEASE OF SECURITY INTEREST IN  
TRADEMARKS dated as of September 25, 2018 (this “Release”),  
by Venture Lending & Leasing VII, Inc. (“VLL7 Lender”) and  
Venture Lending & Leasing VIII, Inc. (“VLL8 Lender” and,  
together with the VLL7 Lender, the “Lenders”).

A. Reference is made to (i) that certain Loan and Security Agreement dated as of June 30, 2017, between Eventbrite, Inc. (the “Borrower”) and the Lenders, as supplemented by the Supplement to the Loan and Security Agreement dated as of June 30, 2017 and as amended by the Amendment No. 1 to the Supplement to Loan and Security Agreement, dated as of May 29, 2018 (as so supplemented and amended, the “2017 Loan Agreement”) and (ii) that certain Loan and Security Agreement dated as of May 29, 2018 between Borrower and VLL8 Lender, as supplemented by the Supplement to the Loan and Security Agreement dated as of May 29, 2018 (as so supplemented, the “2018 Loan Agreement” and together with the 2017 Loan Agreement, the “Loan Agreements”).

B. (i) Pursuant to the 2017 Loan Agreement, the Borrower granted to the Lenders a security interest in all right, title and interest of the Borrower in, among other things, the trademarks set forth on Schedule I-A hereto, and such security interest was recorded with the United States Patent & Trademark Office (the “USPTO”) on July 6, 2017 at Reel/Frame 6099/0863 and (ii) pursuant to the 2018 Loan Agreement, the Borrower granted to VLL8 Lender a security interest in all right, title and interest of the Borrower in, among other things, the trademarks set forth on Schedule I-B hereto (together with the trademarks set forth on Schedule I-A, the “Trademark Collateral”), and such security interest was recorded with USPTO on May 29, 2018 at Reel/Frame 6390/0424.

C. Pursuant to the Payoff Letter dated as of September 25, 2018, among the Borrower and the Lenders, each Lender agreed to release any and all liens and security interests it may have in the Trademark Collateral pursuant to the Loan Agreements.

Accordingly, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Lenders hereby state as follows:

SECTION 1. Terms. Each capitalized term used but not otherwise defined herein shall have the meaning specified in the 2017 Loan Agreement or the 2018 Loan Agreement, as applicable.

SECTION 2. Release. Each Lender, on behalf of itself and its permitted successors and assigns, does hereby terminate the 2017 Loan Agreement and the 2018 Loan Agreement, as applicable, and, release, relinquish and discharge its and their lien and security interest granted under the Loan Agreements in the Trademark Collateral and any right, title or interest granted under the Loan Agreements it has in the Trademark Collateral shall hereby cease and become void. This Release is made without representation or warranty by, or recourse to, the Lenders.

SECTION 3. Further Assurances. Each Lender hereby authorizes the Borrower or the Borrower's authorized representative to record this Release with the USPTO. Each Lender hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect and record the release of the security interest contemplated hereby, solely at the Borrower's cost.

AND GOVERNED BY THE LAWS OF THE STATE OF CALIFORNIA.
