PARTIAL RELEASE OF TRADEMARK SECURITY INTEREST

This Partial Release of Trademark Security Interest (this "Partial Release") is made effective as of September 27, 2018 by JPMorgan Chase Bank, N.A., as Administrative Agent (the "Administrative Agent") for the Secured Parties, to LIFETIME BRANDS, INC., a Delaware corporation (the "Borrower"), as follows:

WHEREAS, on March 2, 2018, Borrower, certain of the other Loan Parties and the Administrative Agent entered into a Pledge and Security Agreement (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Security Agreement"), and on the date thereof the Borrower and the Administrative Agent entered into a Confirmatory Grant of Security Interest in United States Trademarks (the "Confirmatory Grant");

WHEREAS, pursuant to the Security Agreement, the Borrower granted to the Administrative Agent, on behalf of the Secured Parties, among other collateral, a continuing security interest in all of the Borrower's right, title and interest, including goodwill, in, to and under its trademarks, including but not limited to the trademark listed on the attached Schedule A;

WHEREAS, the Confirmatory Grant was recorded in the United States Patent and Trademark Office (the "USPTO") on March 6, 2018, at reel/frame 6284/0212; and


WHEREAS, the Administrative Agent wishes to release its security interest in the trademark listed on Schedule A only and retransfer and reassign to the Borrower without recourse any of the Administrative Agent's right, title and interest in and to the trademark listed on Schedule A.

NOW, THEREFORE, the Administrative Agent hereby releases, terminates and discharges any security interest it may have under the Security Agreement or the Confirmatory Grant in the trademark listed on Schedule A only, and reassigns any and all right, title and interest it may have in and to the trademark listed on Schedule A without recourse to the Borrower, and such security interest shall hereby terminate, cease and become void; and the Administrative Agent hereby consents to the recording of this Partial Release with the USPTO.
