NUNC PRO TUNC TRADEMARK ASSIGNMENT AGREEMENT

THIS TRADEMARK ASSIGNMENT AGREEMENT (the "Assignment") is entered into effective nunc pro tunc as of February 26, 1999 by and between American Promotional Events, Inc. – East, formerly known as American Promotional Events of Alabama, Inc. (an Alabama Corporation) ("Assignor") and American Promotional Events, Inc. (an Alabama Corporation) ("Assignee").

WHEREAS, Assignor's predecessor in interest and affiliated company, Pyrodyne American Corporation, assigned its rights in the trademark registration identified in Exhibit A, incorporated herein by reference (the "Trademark") and all goodwill associated therewith, to Assignor on January 2, 1996, under Assignor's then name, American Promotional Events, Inc. (an Alabama corporation).

WHEREAS, Assignor was previously known as American Promotional Events, Inc. (an Alabama corporation) December 29, 1994 until December 31, 1998, at which time it changed its name to American Promotional Events of Alabama, Inc. (an Alabama corporation) ("Alabama I"); and

WHEREAS, Assignor's affiliated company, American Promotional Events, Inc. (an Alabama corporation) was also previously known as American Promotional Events of Alabama, Inc. (an Alabama corporation) from September 24, 1997 until October 5, 1998, and ultimately changed its name to American Promotional Events, Inc. (an Alabama corporation) as of February 26, 1999 ("Alabama II"); and

WHEREAS, Assignor ("Alabama I") changed its name from American Promotional Events of Alabama, Inc. (an Alabama corporation) to American Promotional Events, Inc.-East (an Alabama corporation) as of March 26, 2002; and

WHEREAS, Assignor and all of said affiliated companies intended that American Promotional Events, Inc., ("Alabama II") be the owner of the Trademark and goodwill associated therewith;

WHEREAS, Assignor is the owner of the Trademark together with the goodwill of the business in connection with which the Trademark is used; and

WHEREAS, Assignor desires to transfer its right, title and interest in and to the Trademark, together with the goodwill associated therewith,

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby transfers and assigns nunc pro tunc as of February 26, 1999, to Assignee its right, title and interest in and to the Trademark, together with the goodwill associated therewith, including all registrations and applications thereto, as well as all renewals and extensions of registrations thereof, including, without limitation, all claims for damages by reason of past, present and future infringement or other unauthorized use of the Trademark, with the right to sue for damages and collect the same for Assignee's own use and enjoyment and for the use and enjoyment of its successors, assigns or other legal representatives.

IN WITNESS WHEREOF, the undersigned, being duly authorized, have caused this Assignment to be executed on this 28<sup>th</sup> day of September, 2018, nunc pro tunc as of February 26, 1999.



