**TERMINATION AND RELEASE OF SECURITY INTEREST**

This TERMINATION AND RELEASE OF SECURITY INTEREST is given by **MADISON PACIFIC TRUST LIMITED**, a limited company incorporated in Hong Kong with a principal place of business at Suite 1720, 17th Floor, Tower One, Admiralty Centre, 18 Harcourt Road, Hong Kong, People's Republic of China (PRC), in its capacity as Collateral Agent pursuant to the Offshore Facility Security Agreement (in such capacity, the "**Collateral Agent**") to **PACTERA TECHNOLOGY INTERNATIONAL LTD.**, a Cayman Islands corporation with a principal place of business c/o Intertrust Corporate Services (Cayman) Limited, 190 Elgin Avenue, George Town, Grand Cayman KY1-9005, Cayman Islands ("**Grantor**").

WHEREAS, Grantor executed and delivered to the Collateral Agent an Offshore Facility Trademark Security Agreement dated as of July 30, 2018 granting to the Collateral Agent a security interest in certain registered trademarks of Grantor and the goodwill associated therewith, which Trademark Security Agreement was recorded with the United States Patent & Trademark Office on July 31, 2018 in Reel 6397 beginning at Frame 0052 (the "**Trademark Security Agreement**");

WHEREAS, said certain trademarks include, *inter alia*, the trademarks embodied in U.S. Trademark Registration Numbers 4324537, 4324536, 4324209 and 4324205 for the trademark "PACTERA" (collectively, the "**Trademarks**"); and

WHEREAS, Grantor has fully satisfied all of its obligations as set forth in the Trademark Security Agreement and related documents and performed all of its obligations to the Collateral Agent under the Trademark Security Agreement and related documents.

NOW, THEREFORE, to all whom it may concern, be it known that, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent does hereby terminate and release in full all liens and security interests created

by and set forth in the Trademark Security Agreement granted by Grantor in favor of the Collateral Agent with respect to the Trademarks and the goodwill associated therewith.


