**ASSIGNMENT OF TRADEMARK**

WHEREAS, **Mitsui Chemicals, Inc.**, a corporation organized under the laws of Japan, with a business address of 5-2, Higashi-Shimbashi 1-chome, Minato-ku, Tokyo, Japan (hereinafter "Assignor") owns the trademark US Reg. No. 4,365,305 for "MILEX" (hereinafter referred to as "the said mark"), which is registered in the United States Patent and Trademark Office as set forth in the attached Schedule "A";


WHEREAS, Mitsui Chemicals, Inc. has submitted the Request to Divide Registration for the said mark to divide "chemical additives for general industrial use in the manufacture of a wide variety of goods, other than resin softener and maleimide; hardeners with an epoxy resin base, namely, hardening agents for industrial use in the manufacture of flexible foams, rigid foams, elastomers and plastics; adhesives for industrial purposes" (hereinafter referred to as "the maintained goods") from "unprocessed synthetic resins; unprocessed plastics in all forms; unprocessed plastics for industrial use; phenolic resins; chemical binding agents for industrial use in the manufacture of textiles, fabrics, furs, molding compounds and paint, other than maleimide; binder resins for general industrial use in the manufacture of a wide variety of goods; chemical binding agents for use in the manufacture of brake pads" (hereinafter referred to as "the assigned goods"); and

WHEREAS, **GUN EI CHEMICAL INDUSTRY CO., LTD.**, a corporation organized under the laws of Japan, with a business address of 700, Shukuorui-machi, Takasaki-shi, Gunma, Japan (hereinafter "Assignee") is desirous of acquiring any and all rights that Assignor may have in and to the said mark and the registration thereof in connection with the assigned goods, together with the goodwill of the business in connection with which the said mark for the assigned goods is used and which is symbolized by the said mark in connection with the assigned goods, along with the right to recover for damages and profits for past infringements thereof in connection with the assigned goods;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged by Assignor, Assignor does hereby assign unto Assignee all right, title and interest in and to the said mark and the registration thereof in connection with the assigned goods in the United States of America, together with the goodwill of the business in connection with which the said mark for the assigned goods is used and which is symbolized by the said mark in connection with the assigned goods, along with the right to recover for damages and profits for past infringements thereof in connection with the assigned goods.

Assignor agrees to execute and deliver at the request of Assignee, all papers, instruments and assignments, and to perform any other reasonable acts that Assignee may require in order to vest all of Assignor's right, title, and interest in and to the said mark for the assigned goods in the Assignee and/or to provide evidence to support any of the foregoing in the event such evidence is deemed necessary by Assignee, to the extent such evidence is in the possession or control of Assignor.
