TERMINATION AND RELEASE OF
SECOND LIEN TRADEMARK SECURITY AGREEMENT

This TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT (“Termination and Release”) dated as of September] 30, 2018, is made from Z CAPITAL COMMERCIAL FINANCE, L.L.C., as administrative agent (the “Agent”) to NITROSTEEL, LLC, a Delaware limited liability company (the “Grantor”). Capitalized terms used in this Termination and Release and not otherwise defined herein have the meanings specified in the Second Lien Guaranty and Collateral Agreement or the Credit Agreement referred to therein or the Second Lien Trademark Security Agreement, as applicable.

WITNESSETH:

WHEREAS, pursuant to that certain Second Lien Guaranty and Collateral Agreement dated as of March 6, 2017, the Grantor executed a Second Lien Trademark Security Agreement of even date, which was recorded in the United States Patent and Trademark Office on April 3, 2017 at Reel 6025, Frame 0257, pursuant to which the Grantor granted a continuing security interest to the Agent, for the benefit of the Lenders, in the Trademark Collateral, including certain trademarks and/or trademark applications listed on Schedule A hereto and made a part hereof.

WHEREAS, the Agent now desires to terminate the Second Lien Trademark Security Agreement and terminate and release its security interest in the Trademark Collateral and reassign any and all rights, title, and interest in the same to Grantor.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:


1. Agent hereby terminates the Second Lien Trademark Security Agreement and terminates and releases its security interest in all of Grantor’s right, title and interest in and to the Trademark Collateral, including those trademarks set forth on Schedule A.

2. Agent hereby assigns, grants and conveys to the Grantor, without any representation, warranty, recourse or undertaking by the Agent, any and all of Agent’s right, title, and interest in and to the Trademark Collateral.
