**RELEASE AND REASSIGNMENT OF  
INTELLECTUAL PROPERTY COLLATERAL**

Reference is hereby made to that certain Intellectual Property Security Agreement (the “**Agreement**”), dated as of January 6, 2017, executed by **AVIONTÉ, LLC**, a Minnesota limited liability company (“**Grantor**”), in favor of Silicon Valley Bank, as Administrative Agent (“**Agent**”), which was recorded in the United States Patent and Trademark Office on January 6, 2017, at Reel 5960 Frame 0935, and pursuant to which the Grantor assigned and granted to Agent, a security interest in and to all of Grantor’s right, title and interest in and to the Intellectual Property Collateral (as defined in the Agreement), including those trademarks specifically listed on Schedule 1 attached hereto (the “**Trademarks**”) and the goodwill associated therewith; and

WHEREAS, Agent wishes to terminate the Agreement and release, transfer and reassign to Grantor, without representation or warranty, all of Agent’s right, title and interest in and to the Intellectual Property Collateral, including the Trademarks and the goodwill associated therewith.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Agent hereby terminates the Agreement and releases, transfers and reassigns to Grantor, without representation or warranty, all of Agent’s right, title and interest in and to the Intellectual Property Collateral, including the Trademarks and the goodwill associated therewith.
