RELEASE OF SECURITY INTEREST IN FIRST LIEN TRADEMARK COLLATERAL

This RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL, dated as of October 1, 2018 (this "Release"), is made by BARCLAYS BANK PLC, as collateral agent (in such capacity, the "Collateral Agent"), in favor of ARETEC GROUP, INC., a Delaware corporation, CETERA FINANCIAL HOLDINGS. INC., a Delaware corporation, INVESTORS CAPITAL HOLDINGS, LLC, a Delaware limited liability company, LEGEND GROUP HOLDINGS, LLC, a Delaware limited liability company and J.P. TURNER & COMPANY, L.L.C., a Georgia limited liability company (the "Grantors", and each, a "Grantor"), as follows:

WITNESSETH

WHEREAS, pursuant to the (a) First Lien Trademark Security Agreement, dated as of May 23, 2016 (the "2016 Trademark Security Agreement") and recorded with the U.S. Patent and Trademark Office on May 24, 2016 at Reel/Frame 5800/0508, (b) First Supplemental First Lien Trademark Security Agreement, dated as of September 14, 2016 (the "First Supplemental Trademark Security Agreement") and recorded with the U.S. Patent and Trademark Office on September 14, 2016 at Reel/Frame 5876/0334, (c) Second Supplemental First Lien Trademark Security Agreement, dated as of May 24, 2017 (the "Second Supplemental Trademark Security Agreement") and recorded with the U.S. Patent and Trademark Office on May 25, 2017 at Reel/Frame 6068/0636, (d) Third Supplemental First Lien Trademark Security Agreement, dated as of December 8, 2017 (the "Third Supplemental Trademark Security Agreement") and recorded with the U.S. Patent and Trademark Office on December 18, 2017 at Reel/Frame 6231/0026 and (e) First Lien Trademark Security Agreement, dated as of September 29, 2017 (the "2017 Trademark Security Agreement", and, together with the 2016 Trademark Security Agreement, the First Supplemental Trademark Security Agreement, the Second Supplemental Trademark Security Agreement and the Third Supplemental Trademark Security Agreement, the "First Lien Trademark Security Agreements") and recorded with the U.S. Patent and Trademark Office on October 3, 2017 at Reel/Frame 6169/0232, as security for the payment or performance, as the case may be, in full of the Obligations, the Grantors under each of the First Lien Trademark Security Agreements pledged to the Collateral Agent, its successors and assigns, for the ratable benefit of the Secured Parties, and granted to the Collateral Agent, its successors and assigns, for the ratable benefit of the Secured Parties, a security interest in all right, title or interest in or to any and all of the following assets and properties then owned or at any time thereafter acquired by a Grantor or in which a Grantor then had or at any time in the future may acquire any right, title or interest (collectively, the "Released Trademark Collateral"):

(a) all Trademarks constituting Collateral owned by the Grantor and all registrations and applications for registration therefor and all renewals thereof (including, without limitation, each Trademark registration and application therefor, with all renewals thereof, referred to in <u>Schedules I</u> through <u>V</u> attached hereto, and all of the goodwill of the business connected with the use of or symbolized by, each Trademark), whether or not currently in use, but excluding any Trademark applications filed in the United States Patent and Trademark Office on the basis of a Grantor's "intent-to-use" such trademark, unless and until

acceptable evidence of use of such Trademark has been filed with the United States Patent and Trademark Office pursuant to Section 1(c) or Section 1(d) of the Lanham Act (15 U.S.C. § 1051 et seq.), whereupon such Trademark application will be deemed automatically included in the Trademark Collateral, but solely to the extent that granting the Security Interest in such Trademark application prior to such filing would adversely affect the enforceability or validity of such Trademark application or any registration issuing therefrom;

- (b) rights in the foregoing provided by international treaties or conventions and all other rights corresponding thereto throughout the world;
- (c) any and all claims for damages and injunctive relief for past, present and future infringement, dilution, misappropriation, violation, misuse or breach with respect to any of the foregoing, with the right to sue for and collect, or otherwise recover, all proceeds and damages relating thereto; and
- (d) all Proceeds and products of any and all of the foregoing, all Supporting Obligations and all collateral security and guarantees given by any Person with respect to any of the foregoing.

WHEREAS, the Grantors have requested that the Collateral Agent release its security interest in all of each Grantor's right, title and interest in or to the Released Trademark Collateral.

NOW, THEREFORE, the Collateral Agent, without recourse, representation or warranty of any kind or nature, and at each Grantor's sole cost and expense, hereby terminates, cancels and releases its security interest in all of each Grantor's right, title and interest in or to the Released Trademark Collateral, including the trademarks listed on <u>Schedules I</u> through <u>V</u> hereto, and any and all right, title and interest of the Collateral Agent in the Released Trademark Collateral shall hereby terminate, cease and become void.

The Collateral Agent authorizes and requests that the Commissioner for Trademarks and any other applicable government officer record this Release.

THIS RELEASE SHALL BE CONSTRUED IN ACCORDANCE WITH AND GOVERNED BY THE LAWS OF THE STATE OF NEW YORK.

Capitalized terms used but not defined herein shall have the meanings given to them in the 2016 Trademark Security Agreement and supplements thereto or the 2017 Trademark Security Agreement, as applicable.
