TERMINATION OF INTELLECTUAL PROPERTY SECURITY AGREEMENT

This TERMINATION OF INTELLECTUAL PROPERTY SECURITY AGREEMENT, dated October 1, 2018 (“Agreement”), is made and entered into among TROPICANA ENTERTAINMENT INC., a Delaware corporation (“Borrower”), NEW TROPICANA HOLDINGS, INC., a Delaware corporation (with Borrower, collectively, the “Loan Parties”), and CREDIT SUISSE AG, CAYMAN ISLANDS BRANCH, as collateral agent (in such capacity, “Collateral Agent”). Capitalized terms used but not otherwise defined herein shall have the meanings assigned thereto in the Credit Agreement (as defined below) or the applicable Loan Document referred to therein.

WHEREAS, Borrower entered into that certain Credit Agreement dated as of November 27, 2013 (as amended, restated, supplemented or otherwise modified, the “Credit Agreement”), with the banks and other financial institutions party thereto, and Credit Suisse AG, Cayman Islands Branch, as administrative agent and collateral agent;

WHEREAS, in order to secure payment of certain Secured Obligations under the Credit Agreement, and pursuant to that certain Guarantee and Collateral Agreement of even date therewith among the Loan Parties, Collateral Agent, and certain other parties thereto (as amended, supplemented or otherwise modified from time to time, the “Collateral Agreement”), each Loan Party entered into that certain Intellectual Property Security Agreement of even date therewith (as amended, supplemented or otherwise modified from time to time, the “IP Security Agreement”) and pledged a continuing security interest in and to all of such Loan Party’s right in the Intellectual Property in favor of Collateral Agent;

WHEREAS, the IP Security Agreement, including supplements thereto, was recorded with (i) the United States Patent and Trademark Office on November 27, 2013, at Reel 5162/Frame 0652, (ii) the United States Patent and Trademark Office on July 3, 2014 at Reel 5316/Frame 0395, (iii) the United States Copyright Office on February 28, 2014 at Volume 9908/Document 270, and (iv) the United States Copyright Office on July 8, 2014 at Volume 9914/Document 274; and

WHEREAS, because Loan Parties have no outstanding obligations to Collateral Agent under the terms of the IP Security Agreement, Collateral Agent has agreed to terminate the IP Security Agreement and release all security interests, pledges, assignments, mortgages and liens granted to it by each Loan Party under the IP Security Agreement;

NOW, THEREFORE, in consideration of the mutual covenants and agreements contained herein, Full Payment of all of the Secured Obligations and other good and valuable consideration, receipt of which is hereby acknowledged, the Loan Parties and Collateral Agent agree as follows:

1. Collateral Agent hereby terminates the IP Security Agreement and discharges and releases all security interests, pledges, assignments, conveyances, hypothecations, transfers, mortgages and liens granted to it in, to and under the Intellectual Property under the IP Security Agreement, including, without limitation: (i) the copyrights and United States copyright registrations listed in the attached Schedule I; and (ii) the trademarks and the United States and foreign trademark registrations listed on the attached Schedule II.
2. The Loan Parties and Collateral Agent hereby authorize all appropriate governmental agencies to record this Agreement.
3. This Agreement (a) shall be binding on, inure to the benefit of, and be enforceable by, each of the parties hereto and their respective successors and assigns and (b) may only be

waived, modified or amended by a written instrument signed by the party against which the enforcement thereof is sought.

4. This Agreement may be executed in any number of counterparts, each of which when so executed shall be deemed to be an original and all of which taken together shall constitute one and the same agreement. Delivery of an executed counterpart of a signature page to this Agreement by facsimile or other electronic transmission shall be effective as delivery of an original executed counterpart of this Agreement.






