RELEASE OF SECURITY INTEREST

This RELEASE OF SECURITY INTEREST, dated September 27, 2018 ("Release"), is made by Icahn Agency Services, LLC (the "Collateral Agent"), in favor of New Tropicana Holdings, Inc., together with any successors and assigns ("Assignee").

A. Reference is made to that certain Debtor-In-Possession Intellectual Property Security Agreement in favor of the Collateral Agent, dated as of February 5, 2015, and recorded on February 25, 2015, at Reel/Frame 5465/0221 in the United States Patent and Trademark Office (as amended, restated, supplemented or otherwise modified from time to time, the "IP Security Agreement"), wherein Trump Entertainment Resorts Inc. ("Grantor") granted a security interest to the Collateral Agent in certain Collateral (as defined in the IP Security Agreement), including in the TAJ MAHAL trademark and associated United States Trademark Registration No. 2,121,189 (the "TAJ MAHAL Mark").

B. Pursuant to that certain Trademark Assignment in favor of Assignee, dated as of March 31, 2017, and recorded on May 8, 2017, at Reel/Frame 6051/0705 in the United States Patent and Trademark Office, Grantor assigned its entire right, title and interest in and to the TAJ MAHAL Mark to Assignee.

C. The Collateral Agent has agreed to release all security interests granted to it in the TAJ MAHAL Mark under the IP Security Agreement.


NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the Collateral Agent hereby agrees as follows:

1. Release. The Collateral Agent hereby discharges, terminates and releases all security interests, pledges, assignments, mortgages and liens granted to it in the TAJ MAHAL Mark under the IP Security Agreement. For avoidance of doubt, the release of security interests set forth herein is limited solely to the TAJ MAHAL Mark and nothing in this Release shall be deemed to amend, modify or supplement the provisions of, or the rights or obligations of Grantor or the Collateral Agent under, the IP Security Agreement.

2. Recording. The Collateral Agent hereby authorizes the Director of the United States Patent and Trademark Office to record this Release to reflect the release of security interests with respect to the TAJ MAHAL Mark.

IN WITNESS WHEREOF, the Collateral Agent has executed this Release as of the date first mentioned above.
