## TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this “*Termination and Release*”) is made as of September 21, 2018 by SILICON VALLEY BANK, as Administrative Agent (the “*Assignee*”), in favor of **CROSS MATCH, INC.**, a Delaware corporation (“*Holdings*”), **CROSS MATCH HOLDINGS, INC.**, a Delaware corporation (“*Parent*”), **CROSS MATCH TECHNOLOGIES, INC.**, a Delaware corporation (“*Borrower*”), **DIGITALPERSONA, INC.**, a California corporation (“*DigitalPersona*”) and **CROSS MATCH TECHNOLOGIES GMBH**, a German limited liability company (*Gesellschaft mit beschränkter Haftung*) (“*German Subsidiary*”); and together with Holdings, Parent, Borrower and DigitalPersona are, individually, each a “*Grantor*”, and collectively, the “*Grantors*”).

**WHEREAS**, Grantors and Assignee entered into (i) that certain Guarantee and Collateral Agreement, dated as of July 13, 2012 (as amended, amended and restated, supplemented, restructured or otherwise modified, renewed or replaced from time to time, the “*Guarantee and Collateral Agreement*”), and (ii) that certain Credit Agreement, dated as of July 13, 2012 (as amended, amended and restated, supplemented, restructured or otherwise modified, renewed or replaced from time to time, the “*Credit Agreement*”), pursuant to which Grantors executed and delivered a Trademark Security Agreement, dated as of July 13, 2012 (as amended, supplemented, and in effect, the “*IP Agreement*”);

**WHEREAS**, the IP Agreement was recorded with the United States Patent and Trademark Office (“*USPTO*”) on July 17, 2012, at Reel 4820, Frame 0740;

**WHEREAS**, the IP Agreement was supplemented by (a) that certain First Supplement to Trademark Security Agreement dated as of April 17, 2014 and recorded with the USPTO at Reel 5263, Frame 0813, (b) that certain Second Supplement to Trademark Security Agreement dated as of June 23, 2015 and recorded with the USPTO at Reel 5559, Frame 0919, and (c) that certain Third Supplement to Trademark Security Agreement dated as of July 20, 2018 and recorded with the USPTO at Reel 6434, Frame 0872;

**WHEREAS**, Grantors have requested that Assignee hereby terminate, release and discharge fully its security interests in and liens on all right, title and interest of Grantors in, to and under the trademark collateral pledged in the Guarantee and Collateral Agreement and the IP Agreement (collectively, the “*IP Collateral*”) as herein provided; and

**WHEREAS**, Grantors have requested that the Assignee provide a document suitable for recording with the USPTO to evidence the release of the Assignee’s security interests in and liens on the IP Collateral as herein provided.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Assignee hereby:

1. terminates the IP Agreement and releases, terminates and discharges all liens and security interests in all right, title and interest of Grantors in, to and under the IP Collateral, including those trademark and service mark registrations and applications identified in Schedule I hereto, and all goodwill associated therewith; and


2. authorizes and requests that this Termination and Release be recorded with the USPTO.
