**RELEASE OF AMENDED AND RESTATED GRANT OF SECURITY INTEREST IN
PATENT AND TRADEMARK RIGHTS**

This Release of Amended and Restated Grant of Security Interest in Patent and Trademark Rights, dated as of September 27, 2018 (this “Release”), is made by Ares Capital Corporation, as collateral agent (the “Collateral Agent”) under that certain Amended and Restated Grant of Security Interest in Patent and Trademark Rights dated as of November 4, 2016 (as amended, supplemented or modified and in effect from time to time, the “IP Security Agreement”) by and among LMK Technologies, LLC, a Delaware limited liability company, Perma-Liner Industries, LLC, a Delaware limited liability company, Paragon Water Systems, Inc., a Florida corporation, Eldon Water Inc., a Delaware corporation, and Nashville Chemical & Equipment Company, a Delaware corporation (collectively, the “Grantors”), and Collateral Agent. Unless otherwise defined herein, terms defined in the IP Security Agreement and used herein shall have the meanings given to them in the IP Security Agreement.

WHEREAS, pursuant to the IP Security Agreement, the Grantors granted to the Collateral Agent a continuing security interest in all of each Grantor’s right, title and interest in, to and under its owned or thereafter acquired Trademarks and Patents, including those set forth on the attached Schedule I (the “IP Collateral”); and


WHEREAS, the Grantors have requested and the Collateral Agent has agreed to provide a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the release, relinquishment and discharge of its security interest in the IP Collateral (the “Released Collateral”).

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Collateral Agent does hereby, in each case, without recourse, representation or warranty of any kind whatsoever, (a) terminate the liens and security interest in the Released Collateral created under the IP Security Agreement and any other document executed in connection therewith, (b) release its security interest in the Released Collateral, (c) discharge any and all rights, title and interest it has in and the security interest granted to the Collateral Agent in the Released Collateral, and (d) assigns, transfers and conveys to Grantor without any representation or warranty of any kind, whether express or implied, any interest in such Released Collateral, including the security interest and any other liens.
