WHEREAS, Assignee, an Assignor affiliate, has been using the Mark in connection with its business; and



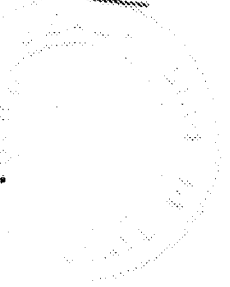
