RELEASE OF SECURITY INTEREST IN TRADEMARKS

This Release of Security Interest in Trademarks ("Release") is executed by BANK OF AMERICA, N.A., successor in interest to Fleet Capital Corporation, in its capacity as administrative and collateral agent for itself and for the Lenders, in favor of MORLEY CANDY MAKERS, INC., successor in interest to Sanders Sales, Inc. ("Company"). Capitalized terms not defined herein shall have the meaning set forth in the Trademark Assignment of Security dated August 30, 1999 and recorded in the United States Patent and Trademark Office on October 4, 1999 at Reel: 1969, Frame: 0896 ("Trademark Assignment of Security").

WHEREAS, pursuant to (i) a certain Loan and Security Agreement dated August 30, 1999 among Company and other Borrowers and Fleet Capital Corporation ("Fleet") and other Lenders (as amended, modified, restated, or otherwise supplemented from time to time, "Loan and Security Agreement"), and (ii) a certain Trademark Collateral Security Agreement dated August 30, 1999 between Company and Fleet as Agent for Lenders (as amended, supplemented, restated or otherwise modified from time to time, "Trademark Collateral Security Agreement"), Company assigned and granted to Agent for the ratable benefit of Agent and Lenders a security interest in and to the marks shown in the attached Schedule A (the "Marks"), together with the goodwill of the business symbolized by the Marks, and registrations and applications therefor, as set forth in the Trademark Assignment of Security.

WHEREAS, Bank of America, N.A., as successor in interest to Agent, has agreed to release its security interests in the Marks, the goodwill of the business symbolized by the Marks, and the registrations and applications therefor.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Bank of America, N.A., as successor in interest to Agent, for itself and for the Lenders, hereby relinquishes, releases, terminates and discharges its security interests in the Marks, the goodwill of the business symbolized by the Marks, and the registrations and applications therefor conveyed to Agent pursuant to the Loan and Security Agreement, the Trademark Collateral Security Agreement, and the Trademark Assignment of Security, and Bank of America, N.A., as successor in interest to Agent, hereby reassigns to Morley Candy Makers, Inc., as successor in interest to Company, any and all such right, title and interest that Bank of America, N.A., as successor in interest to Agent, may have in the Marks, the goodwill of the business symbolized by the Marks, and the registrations and applications therefor. Bank of America, N.A., as successor in interest to Agent, further agrees to execute and deliver to Morley Candy Makers, Inc., as successor in interest to Company, any and all further documents or instruments and do any and all further acts which Morley Candy Makers, Inc. (or Morley Candy Makers, Inc.'s agents or designees) reasonably request, at the expense of Morley Candy Makers, Inc., in order to confirm this Release and Morley Candy Makers, Inc.'s right, title and interest in and to the Marks, the goodwill of the business symbolized by the Marks, and the registrations and applications therefor.

This release is made without any representation, warranty or recourse by Agent.
