**TERMINATION AND RELEASE OF

WHEREAS, the Lender has agreed to terminate and release its security interest and all of its right, title and interest in each of the Marks, as herein provided.


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Lender hereby agrees as follows:

The Lender hereby discharges, terminates and releases its security interest in all of the Marks, and the Lender hereby assigns and transfers to the Company, without recourse, all of the Lender's right, title and interest in and to each of the Marks and the related registrations and goodwill, effective as of the date set forth above.

2. Further Assurances. Lender hereby agrees to execute, acknowledge and deliver all such further instruments and to take all such further actions as may be reasonably requested or are required in order to more fully and effectively carry out the purposes of this Release Agreement at the Company's sole cost and expense.
