Please be advised that pursuant to that certain Loan and Security Agreement, dated as of the date hereof (as the same be amended, restated, amended and restated, supplemented, extended or otherwise modified from time to time, the "Loan Agreement"), by and among MANN LAKE INTERMEDIATE, INC., a Delaware corporation ("Mann Lake Intermediate"), MANN LAKE ACQUISITION, INC., a Delaware corporation ("Mann Lake Acquisition" and together with Mann Lake Intermediate, collectively the "Initial Borrowers" and each an "Initial Borrower"), and following the consummation of the Closing Date Acquisition (as hereinafter defined), MANN LAKE HOLDING, INC., a Minnesota corporation ("Holdings"), MANN LAKE, LTD., a Minnesota corporation ("Mann Lake"), RDN INDUSTRIES, INC., a Minnesota corporation ("RDN" and together with Mann Lake Holding and Mann Lake, each, as a Borrower), MANN LAKE GUARANTOR LLC, a Delaware limited liability company ("Guarantor"), the other Loan Parties from time to time party thereto, the Lenders (as defined therein) from time to time party thereto, and CRESCENT AGENCY SERVICES LLC, as administrative agent and collateral agent for the Lenders (in such capacity, together with its successors and assigns in such capacity, "Administrative Agent"), Mann Lake has granted to the Administrative Agent a continuing first priority security interest in and continuing lien upon, among other things, the Trademarks set forth on Exhibit A hereto. Capitalized terms used herein but not defined herein shall have the meanings given in the Loan Agreement.
