TRADEMARK ASSIGNMENT

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Climb On hereby sells, conveys, assigns and transfers to SKI all of Climb On's right, title and interest of any nature in and to the Mark, together with:

1. the goodwill of the business relating to the goods and services of the business on which the Mark is used and are symbolized by the Mark;
2. all income, royalties, and damages hereafter due or payable to Climb On with respect to the marks, including without limitation, damages, and payments for past or future infringements and misappropriations of the marks, and
3. all rights to sue for past, present and future infringement or misappropriations of the marks.

Climb On further covenants that it will take all actions that may be necessary for securing, completing, or vesting in SKI full right, title, and interest in the mark and its related property.
