CONFIRMATORY TRADEMARK RIGHTS ASSIGNMENT


WHEREAS, Correvio and Cardiome wish to execute this Confirmatory Assignment for recordation with worldwide Trademark Offices.

Correvio hereby authorizes and requests the worldwide Trademark Offices to issue all registrations and renewal certificates on said applications and registration to Cardiome.
