**Release of Security Interest in Intellectual
Property**

WHEREAS, Kraus Properties LP acting by its general partner Kraus Properties Inc. ("KPLP"), a limited partnership formed under the laws of the province of Ontario, granted a security interest in favour of Wells Fargo Capital Finance Corporation Canada (the "**Secured Party**"), in certain intellectual property, including, without limitation, the United States trademarks and trademark registrations listed on Schedule "A" hereto (the "**Released IP**");

AND WHEREAS the Secured Party has irrevocably and unconditionally agreed to (i) release its security interest covering the Released IP, (ii) restore all right, title and interest in and to the Released IP to the current registered owner of the Released IP, and (iii) dissolve and terminate any and all liens and encumbrances in favour of the Secured Party with respect to the Released IP.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Secured Party does hereby release its security interest in the Released IP, and discharges, any and all right, title and interest it has in and to the Released IP.

The Secured Party hereby directs USPTO to record the present release in such places as it deems necessary or advisable to give effect hereto.


The Secured Party shall, at the request and cost of KPLP, take all further actions, and provide to KPLP, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by KPLP to more fully and effectively release, terminate and extinguish any such liens and security interests upon the Released IP;

This release shall be binding upon the Secured Party's assigns and successors.
