## CORRECTED ASSIGNMENT OF INTELLECTUAL PROPERTY

This Corrected Assignment of Intellectual Property (“Assignment”) is entered into by and between Seminole Tribe of Florida, Inc., (STOFI), a Federal corporation located at 6300 Stirling Road, Hollywood, Florida 33024 (hereinafter called “the Assignor”) and Bol Management Group, LLC, (BMG), a Florida limited liability company, with an address of One Seminole Way, Hollywood, Florida 33314 (hereinafter called “the Assignee”) (collectively “the Parties”).

This Assignment shall be effective as of March 22, 2017 (“Effective Date”).

### Recitals

WHEREAS, since at least May 2013, Assignor and Assignee have dedicated time, effort, and expense into developing and marketing a restaurant under The Bol brand;

WHEREAS, Assignor has filed the United States Trademark Application No. 87381292, for THE BOL AUTHENTIC ASIAN CUISINE and design, in International Class 043, on March 22, 2017 (the "Intellectual Property");

WHEREAS, by Assignment of Intellectual Property, executed by the parties on May 4, 2017 and May 12, 2017, respectively, Assignee is entitled to half (50%) of the right, title, goodwill, and interest in the Intellectual Property; and

WHEREAS, Assignor seeks to give, grant, sell, transfer, convey and assign (collectively “assign”) to Assignee half (50%) of its right, title, goodwill, and interest in the Intellectual Property.

WHEREAS, this Corrected Assignment is being entered into to correct a ministerial error with respect to STOFI.

### Assignment

NOW, THEREFORE, for consideration, the sufficiency and receipt of which is hereby acknowledged, Assignor and Assignee agree to the following terms:

- A. Rights Assigned. Assignor does hereby assign unto Assignee half (50%) of Assignor’s right, title, goodwill, and interest in the Intellectual Property as stated above to be held, enjoyed, prosecuted, and maintained by Assignor and Assignee, for their mutual use and enjoyment, and for the use and enjoyment of their successors and assigns, or other legal representatives, for the full life of the Intellectual Property as fully and entirely as the same would have been held and enjoyed by Assignor if this Assignment had not been entered into by the parties.
- B. Warranty. Assignor hereby represents and warrants that Assignor has the full power, authority and right to assign the Intellectual Property as herein provided; that Assignor

has not previously granted, conveyed, licensed, sold, transferred, or assigned to any other party any right, title, goodwill, or interest in or to the Intellectual Property, nor will Assignor unilaterally hereafter do any of the foregoing.


C. Assignment. This Assignment and all obligations and undertakings hereunder shall inure to the benefit of Assignor and Assignee and their respective employees, agents, successors, assigns, transferees, heirs and executors.

D. (a) This Assignment may be executed in several counterparts, each of which shall be deemed an original and all of which shall constitute one and the same instrument, and shall become effective when counterparts have been signed by each of the Parties and delivered to the other Parties; it being understood that all Parties need not sign the same counterparts.

(b) The exchange of copies of this Assignment and of signature pages by facsimile transmission (whether directly from one facsimile device to another by means of a dial-up connection or whether mediated by the worldwide web), by electronic mail in "portable document format" (".pdf") form, or by any other electronic means intended to preserve the original graphic and pictorial appearance of a document, or by combination of such means, shall constitute effective execution and delivery of this Assignment as to the Parties and may be used in lieu of the original Assignment for all purposes. Signatures of the Parties transmitted by facsimile shall be deemed to be their original signatures for all purposes.
