## RELEASE OF TRADEMARK SECURITY AGREEMENT

THIS RELEASE OF TRADEMARK SECURITY AGREEMENT (this "Release") is made as of October 5th, 2018, by Bank of America, N.A. (as successor to Bank Boston, N.A.), as Agent (the "Agent") to The Fletcher-Terry Company, LLC, a Connecticut limited liability company (the "Grantor"). Reference is hereby made to that certain Mortgage, Assignment and Security Agreement between the Grantor and the Agent dated April 1, 1999 recorded with the United States Patent and Trademark Office ("USPTO") on April 2, 1999 at Reel 1881/ Frame 0589 (the "Trademark Security Agreement"). Terms used but not defined in this Release shall have the meanings given thereto in the Trademark Security Agreement.

WHEREAS, pursuant to the Trademark Security Agreement, the Agent was granted a security interest in and to the intellectual property described therein, including the Trademarks listed in Schedule A (the "Trademark Collateral");

WHEREAS, the Grantor has requested that the Agent terminate and release its security interests in and to the Trademark Collateral and execute and deliver evidence of such termination and release for filing with the USPTO; and

WHEREAS, the Agent has agreed to such termination and release.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Agent hereby releases and terminates all security interests and other interests it may have in the Trademark Collateral. The Grantor (or its designee) is hereby authorized to file this Release with the USPTO and any other governmental authority.

The delivery of an executed counterpart of a signature page to this Release by email or facsimile shall be effective as delivery of a manually executed counterpart of this Release. The validity, construction and effect of this Release shall be governed by the laws of the State of Wisconsin (without giving effect to its principles of conflicts of law) and shall relate solely to the Trademark Security Agreement.
