**RELEASE OF SECURITY INTEREST  
IN TRADEMARKS**

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”) is dated October 11, 2018, by JPMorgan Chase Bank, N.A., as collateral agent (the “Collateral Agent”), in favor of WEB.COM GROUP, INC. (the “Grantor”).

WHEREAS, Grantor, a Delaware corporation and the Collateral Agent entered into that Guarantee and Collateral Agreement dated as of September 9, 2014 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Security Agreement”) by and among the Grantor, the other grantors from time to time party thereto and the Collateral Agent; and

WHEREAS, pursuant to the Security Agreement, the Grantor executed and delivered to the Collateral Agent that certain Grant of Security Interest in Trademark Rights dated as of September 9, 2014 (the “Trademark Security Agreement”) and recorded with the United States Patent and Trademark Office (“USPTO”) on November 12, 2014 at Reel/Frame No. 5400/0143, pursuant to which the Grantor assigned, pledged and granted to the Collateral Agent, its successors and assigns, for the benefit of the Secured Parties (as defined in the Security Agreement), a security interest in all right, title and interest in or to any and all of the Collateral (as defined in the Trademark Security Agreement); and


WHEREAS, in connection with the payoff of the obligations secured by the Collateral, the Grantor has requested that the Collateral Agent release, and the Collateral Agent desires to release, its security interest in all right, title and interest in and to the Secured Trademarks.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby DISCHARGES, TERMINATES and RELEASES, without recourse, representation or warranty, the Trademark Security Agreement and its security interest in all right, title and interest in or to any and all of the Collateral, including the trademark registrations and, trademark applications set forth in Schedule A attached hereto and incorporated herein by reference, and agrees that the security interest in the Collateral is hereby discharged, terminated and released. The undersigned hereby transfers and assigns to the Grantor, without recourse, representation or warranty, any and all right, title and interest that the Collateral Agent may have obtained in, to and under the Collateral under the Security Agreement or the Trademark Security Agreement, together with the goodwill of the business symbolized thereby, and agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release contemplated hereby.






