
WHEREAS, Carebay Europe Ltd. (hereinafter "Carebay"), a corporation, organized under the laws of Malta, having a mailing address of 57 Tigne Palace, Bisazza Street, Sliema - SLM 1643, Malta, owns an undivided interest in certain intellectual property rights which include without limitation any and all inventions, issued patents (U.S. and foreign), pending patent applications (U.S. and foreign), design rights, renewals or extensions of and rights to claim priority from such rights, and all similar or equivalent rights or forms of protection which subsist or will subsist now or in the future in any part of the world, trade secrets, processes, formulas, product designs, product requirements, specifications, research data, other proprietary know-how, royalties and other rights as a licensor under all existing non-exclusive license agreements for the technology described and patented in the properties identified in Schedule A attached, all claims and benefits of any kind against third parties rights to relief for known or unknown past infringement, and all original records or other materials relating to the intellectual property shown and described in the attached Schedule A, including materials in the possession of Carebay's attorneys, agents, contractors or other third parties (hereinafter all the above property rights collectively referred to as the "Carebay Intellectual Property Rights");

WHEREAS, SHL Medical AG (hereinafter "SHL"), a corporation organized under the laws of Switzerland and located at Gubelstrasse 22, 6300 Zug, Switzerland, desires to acquire the Carebay Intellectual Property Rights;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Carebay has sold, assigned, and transferred, to SHL, its successors, legal representatives and assigns, Carebay's entire right, title and interest in the Carebay Intellectual Property Rights, the same to be held and enjoyed by SHL, for its own use and the use of its successors, legal representatives, and assigns forever and to the full end of the term or terms for which the Carebay Intellectual Property Rights are or may be granted, as fully and entirely as the same would have been held and enjoyed by Carebay, had this Assignment not been made; including the right to bring and

defend proceedings, and obtain and retain any relief recovered (including damages or an account of profits) in respect of any infringement, or any other cause of action arising from ownership, of any of the Carebay Intellectual Property Rights whether occurring before, on, or after the date of this Assignment;

AND for the same consideration noted above, Carebay will, upon request of SHL, execute and deliver all papers, documents, and things, including applications for patents, payment of maintenance fees, and do such other legal acts as may be necessary to enforce, obtain and maintain proprietary rights in in the Carebay Intellectual Property Rights in any and all countries and to vest title thereto in SHL.

The effective date of this Assignment is 17th September October, 2018.
