RELEASE OF GRANT OF SECURITY INTERESTS IN TRADEMARKS

THIS RELEASE OF GRANT OF SECURITY INTERESTS IN TRADEMARKS dated October 12, 2018 by BMO HARRIS BANK N.A., a national banking association ("*BMO Harris*"), with its mailing address at 111 West Monroe Street, Chicago, Illinois 60603, acting as administrative agent hereunder for the Secured Parties as defined in the Grant of Security Interests referred to below (BMO Harris acting as such administrative agent being hereinafter referred to as the "*Administrative Agent*");

WITNESSETH:




