RELEASE OF SECURITY INTEREST IN TRADEMARK RIGHTS

This RELEASE OF SECURITY INTEREST IN TRADEMARK RIGHTS ("Release"), effective as of October 12, 2018, given by **JPMORGAN CHASE BANK, N.A.**, a national banking association, with an address at 10 S. Dearborn, 7th Floor, Chicago, IL 60603, as Administrative Agent ("Agent") to **GOODRX, INC.**, a Delaware corporation with an address at 233 Wilshire Blvd., Suite 990, Santa Monica, CA 90401, **IODINE, INC.**, a Delaware corporation with an address at 233 Wilshire Blvd., Suite 990, Santa Monica, CA 90401, and **GOODRX INTERMEDIATE HOLDINGS, LLC**, a Delaware limited liability company with an address at 233 Wilshire Blvd., Suite 990, Santa Monica, CA 90401 (each, a "Grantor", and collectively, the "Grantors"), as follows:

W I T N E S S E T H

WHEREAS, pursuant to that certain Credit Agreement dated as of April 14, 2017 (as amended, restated, supplemented or otherwise modified from time to time, the "Credit Agreement"), the Lenders (as defined in the Credit Agreement) have agreed to extend credit to the Borrower (as defined in the Credit Agreement);

WHEREAS, in connection with the Credit Agreement, the Grantors executed that certain Guarantee and Collateral Agreement, dated as of April 14, 2017 (as amended, restated, supplemented or otherwise modified from time to time, the "Collateral Agreement") and granted to the Agent a security interest in the United States trademark registration and applications set forth on Schedule A attached hereto (the "Trademarks") to secure the Obligations (as defined in the Collateral Agreement);

WHEREAS, in furtherance of the Collateral Agreement, the Grantors executed a Trademark Security Agreement, dated April 14, 2017 (the "Trademark Security Agreement"), which was recorded by the U.S. Patent and Trademark Office on April 14, 2017, at Reel / Frame no. 6033 / 0752;

WHEREAS, the Agent wishes to release and restore all right, title and interest in and to the Trademarks to the Grantors and to terminate the encumbrance created by the Trademark Security Agreement and the Collateral Agreement in respect of the Trademarks.


NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the Agent hereby terminates, releases, cancels, relinquishes and discharges the security interest in the Trademarks created by the Trademark Security Agreement and the Collateral Agreement and reassigns all right, title and interest it has in the Trademarks to the Grantors.

THIS RELEASE SHALL BE GOVERNED BY AND CONSTRUED IN ACCORDANCE WITH THE LAWS OF THE STATE OF NEW YORK AND SHALL BE BINDING UPON THE GRANTOR'S AND THE COLLATERAL AGENT'S REPRESENTATIVES, SUCCESSORS, ASSIGNS AND TRANSFEREES.
