NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereby agree as follows:

Assignor is the sole and exclusive owner of the entire and unencumbered right, title and interest in and to the Assigned Property, free and clear of any liens, charges and encumbrances, including, without limitation, licenses and covenants by Assignors not to sue third persons, and Assignor hereby assigns to Assignee, its successors and assigns, their entire right, title and interest in and to the Trademarks, and all rights and privileges pertaining to said Trademarks in conformance with 15 U.S.C. §1060; 37 C.F.R. §3.16, together with the goodwill of the business symbolized by the Trademarks, including all income, royalties, damages, and payments now or hereafter due or receivable in respect of the Trademarks, and all causes of action (either in law or equity) and the right to sue, counterclaim, and recover for past, present, and future infringements, misappropriations, or dilutions of the rights assigned to Assignee hereunder, and all rights corresponding thereto throughout the world.

2. The Trademarks are subsisting and have not been adjudged invalid or unenforceable, in whole or in part.

3. And for the above-named consideration, Assignor does hereby agree to, at the request of the Assignee, execute any and all papers and documents and do all other and further
