NOW, THEREFORE, Assignor and Assignee hereby agree as follows:



Assignor agrees to provide all assistance reasonably requested by Assignee in the establishment, recordation and enforcement of Assignee's rights in and to the Trademark.

2. Assignor hereby authorizes and requests the competent authorities to record this Assignment and to grant and issue any and all registrations of the Trademark throughout the world to Assignee, its successors, or assigns, whose rights, title, and interests in such registration are the same as would have been held and enjoyed by Assignor had this Assignment not been made.
