## AFFIDAVIT OF ASSIGNMENT

I, Tom York, President of Fire & Life Safety America, Inc., a Virginia corporation ("FLSA Inc."), do hereby affirm in good faith and with personal knowledge that the following facts and matters as set forth below are true and correct to the best of my knowledge:

1. The trademark/servicemark "Affordable Fire Protection" was registered with the United States Patent and Trademark Office ("USPTO") on July 21, 1998 and was assigned the Registration Number 2174259 (the "Mark").
2. The listed owner of the Mark on the USPTO website is currently shown as Affordable Fire Protection, Inc. a Georgia corporation ("Affordable Fire Protection Inc.")
3. On August 31, 2007, Affordable Fire Protection Inc. was purchased pursuant to an Asset Purchase Agreement dated August 31, 2007 (the "Purchase Agreement") by East Coast Fire Protection Inc., a Virginia corporation ("ECFP Inc.").
4. Pursuant to the Purchase Agreement, ECFP Inc. purchased all the assets of Affordable Fire Protection Inc., including all intellectual property, which included but was not limited to, all Trademark and service mark applications and registrations, including the Mark.
5. Through an oversight, an assignment of the Mark from Affordable Fire Protection Inc. as Assignor and ECFP Inc. as Assignee has never been recorded with the USPTO.
6. Through a series of reorganizations and name changes, ECFP Inc. is now legally known as Fire & Life Safety America, Inc., a Virginia corporation.

We respectfully request that an Assignment be recorded with the USPTO acknowledging and confirming that Fire & Life Safety America, Inc., a Virginia corporation, is the current owner of the Mark: **AFFORDABLE FIRE PROTECTION**, Registration Number 2174259.
