## INTELLECTUAL PROPERTY SECURITY AGREEMENT

This Intellectual Property Security Agreement, is entered into this 1st day of September, 2018 (the "Security Agreement") by and between Bibo Barmaid, LLC, a New Jersey Limited Liability Company with a place of business at 6 Sunrise Circle, Clinton, NJ 08809 (the "Borrower") and Lorri W. Cooper, Medley, Behrens & Lewis LLC, an Ohio Limited Liability Company, with a place of business at 6100 Rockside Woods Blvd., Suite 440, Independence, OH 44131 (the "Lender").

### RECITALS

This Security Agreement is a supplement to that certain Loan Agreement, dated as of the date herein, by and between the Borrower and Lender (the "Loan Agreement").

This Corporate IP Security Agreement is executed for the purpose of filing a short form security agreement in the United States Patent and Trademark Office (the "USPTO"), which sets forth the Borrower's pledge of its intellectual property as security for the Indebtedness Borrower owes the Lender as set forth in the Loan Agreement and all other Loan Documents.

### GRANT OF SECURITY INTEREST

The Borrower hereby grants to the Lender a security interest in and lien on all of the intellectual property assets owned by the Borrower, including without limitation all patents and trademarks, including: : U.S. Patent No. 9,695,030; U.S. Patent No. 9,932,218; U.S. Patent Application Nos. 15/640769, 29/556905, 15/060716, 15/943778, 15/449949, 29/556912; and any later filed patent applications that claim priority to or are part of the chain of title of the identified Collateral, or other later filed applications that are owned by Borrower, and U.S. Trademark Registration Nos. 4998888, 4998889, 5201950, and 5317628, wherever located and whether now owned or hereafter acquired, all goodwill of the business of the Borrower connected with the use of, or otherwise symbolized by, such intellectual property, all rights to sue for infringement of such intellectual property, and all parts, replacements, substitutions, profits, products, amendments, updates and cash and non-cash proceeds of any of the foregoing (including insurance proceeds, of any kind, including those payable by reason of loss or damage thereto) in any form and wherever located, and all written or electronically recorded books and records relating to any such assets and other rights relating thereto, wherever located and whether now owned or hereafter acquired (collectively the "Collateral").


### REPRESENTATIONS, WARRANTIES, COVENANTS AND MISCELLANEOUS
