TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT

THIS TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT (this "Termination"), is dated as of December 28, 2017, and made by **PNC BANK, NATIONAL ASSOCIATION** ("Grantee") in favor of **SUWANNEE RIVER MULCH, LLC**, a Delaware limited liability company ("Grantor").

WHEREAS, pursuant to that certain Intellectual Property Security Agreement, dated as of January 1, 2017 (the "IP Security Agreement"), made by Grantor in favor of Grantee, a security interest was granted by Grantor to Grantee in certain collateral, including the IP Collateral (as defined below);

WHEREAS, the IP Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office (the "USPTO") on January 20, 2017, at Reel 5970 and Frame 0681;

WHEREAS, Grantee now desires to terminate and release the IP Security Agreement.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, Grantee hereby states as follows:

1. Definitions. The term "IP Collateral," as used herein, shall have the meaning given to such term in the IP Security Agreement, and shall include, without limitation, the trademarks and trademark applications listed on Schedule A hereto.

2. Release of Security Interest. Grantee hereby terminates the IP Security Agreement and terminates, cancels, releases and discharges the pledge and hypothecation and lien on and security interest in and to the right, title and interests in, to and under all of the IP Collateral and reassigns to the person or persons legally entitled thereto all right, title and interest of Grantee in the IP Collateral, and any right, title or interest of the Grantee in such IP Collateral shall hereby cease and be void.

3. Authorization. Grantee authorizes the recordation of this Termination with the USPTO at Grantor's expense by Grantor or anyone authorized by Grantor.
