**NOTICE OF RELEASE  
OF SECURITY INTEREST IN TRADEMARKS**

This **NOTICE OF RELEASE OF SECURITY INTEREST IN TRADEMARKS** ("Notice of Release"), effective as of October 1, 2018, is made by **WELLS FARGO BANK, NATIONAL ASSOCIATION**, a national banking association, as Agent (as defined in the Trademark Security Agreement (as defined below)).

**WHEREAS**, **NCH MANAGEMENT SYSTEMS, INC.**, a California corporation with an address of 675 Placentia Avenue, Suite 300, Brea, California 92821 ("**Grantor**"), made that certain Trademark Security Agreement, dated as of July 26, 2017, in favor of Agent, which was recorded in the records of the United States Patent and Trademark Office ("**USPTO**") on July 28, 2017 at Reel 6117, Frame 0099 (as amended, restated, supplemented, or otherwise modified from time to time prior to the date hereof, the "Trademark Security Agreement"), whereby Grantor granted to Agent a continuing security interest in all of its right, title and interest in all of its trademark registrations and applications, including, without limitation, each trademark listed on Schedule A attached hereto (the "Trademarks"); and

1. **Release of Security Interest.** For valuable consideration, Agent hereby terminates, discharges and releases the Trademark Security Agreement and any and all mortgages, liens and security interests in the Trademarks granted to Agent pursuant to the Trademark Security Agreement, in each case without representation, warranty or recourse of any kind, and any right, title or interest of Agent in such Trademarks pursuant to the Trademark Security Agreement shall hereby cease and become void.


2. **Authorization.** Agent authorizes this Notice of Release to be recorded with the USPTO.
