RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release") is made as of September 17, 2018 (the "Effective Date") by Regions Bank, as collateral agent (in such capacity, the "Collateral Agent") in favor of Insomnia Cookies, LLC, a Delaware limited liability company (the "Company").

WHEREAS, pursuant to that certain Pledge and Security Agreement dated as of June 30, 2017 (as the same may have been amended, modified, extended or restated from time to time, the "Agreement"), by and among the Obligors party thereto (each, an "Obligor" and collectively, the "Obligors") and the Collateral Agent for the holders of the Secured Obligations referenced therein, the Company granted to the Collateral Agent, for the benefit of the holders of the Secured Obligations, a continuing security interest in and a right to set off against any and all right, title and interest of Company in and to the Trademarks (as defined in the Agreement), including the trademarks and trademark applications shown on the attached Schedule 1;

WHEREAS, a Notice of Grant of Security Interest in Trademarks evidencing the security interest in the Trademarks granted pursuant to the Agreement was recorded with the United States Patent and Trademark Office ("PTO") on June 30, 2017 at Reel 6096, Frame 0257; and

WHEREAS, the Collateral Agent has agreed to release all of its continuing security interest in and right to set off against the Trademarks.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Collateral Agent agrees as follows:

Section 1. Defined Terms. Capitalized terms used but not defined herein shall have the meanings ascribed to such terms in the Agreement.

Section 2. Termination and Release. The Collateral Agent, without representation, warranty, or recourse, hereby releases and relinquishes its continuing security interest in and right to set off against any and all right, title and interest of Company in and to the Trademarks, including the trademarks and trademark applications shown on the attached Schedule 1, granted pursuant to the Agreement.

Section 3. Recordation. The Collateral Agent hereby authorizes and requests that the United States Commissioner of Patents and Trademarks and any other applicable officer in any successor office or any similar office in any other country record this Release at the Company's expense.

IN WITNESS WHEREOF, the Collateral Agent has caused this Release to be executed as of the Effective Date.
