**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

**WHEREAS**, the Trademarks are forth herein in Schedule A; and

**WHEREAS**, the obligations and requirements of the Loan Agreement for discharge of the liens, obligations, and security interests in the Company's Trademarks were fully satisfied on or by October 31, 2017.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Secured Party hereby, as of the Effective Date, terminates, cancels, and releases and all security interests, liens, and obligations it has in and against the Trademarks as set forth in Schedule A.

The parties hereto agree that, at any time and from time to time upon written request of the other party, each party will execute and deliver such documents and do such further acts as may be reasonably requested by the other party in order to effect the purposes of this Release.
