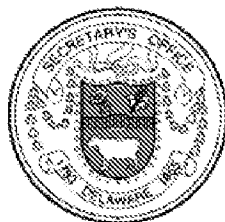

Red Hat, Inc., a corporation formed and existing under and by virtue of the General Corporation Law of the State of Delaware does hereby certify that:

FIRST: The name and state of formation or organization of each of the constituent entities of the merger (the “**Constituent Entities**”) is as follows:

SECOND: An Agreement and Plan of Merger, by and between the Constituent Entities, the “**Merger Agreement**”), dated as of November 30, 2017, has been approved, adopted, certified, executed and acknowledged by each of the Constituent Entities in accordance with the provisions of Section 18-209 of the Limited Liability Company Act of the State of Delaware and Section 264 of the General Corporation Law of the State of Delaware.
