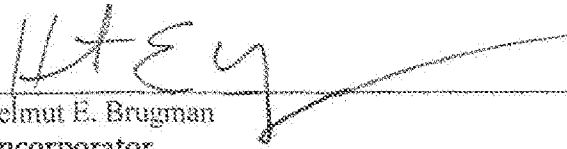

CERTIFICATE OF INCORPORATION
A STOCK CORPORATION

The undersigned Incorporator, desiring to form a corporation pursuant to the General Corporation Law of the State of Delaware, hereby certifies as follows:

1. The name of the Corporation is Quantum Market Research, Inc.
2. The Registered Office of the corporation in the State of Delaware is located at 1209 North Orange Street, in the City of Wilmington, Delaware, 19801, County of New Castle. The name of the Registered Agent at such address upon whom process against this corporation may be served is The Corporation Trust Company.
3. The purpose of the Corporation is to engage in any lawful act or activity for which corporations may be organized under the General Corporation Law of Delaware.
4. The aggregate number of shares which the Corporation shall have the authority to issue shall be five thousand (5,000) shares of voting common stock and five thousand (5,000) shares of nonvoting common stock. The par value of each of said shares shall be ten cents (\$0.10). All shares of the voting and nonvoting common stock shall be identical in all respects, except that the shares of nonvoting common stock shall carry no right to vote on any matter presented to the shareholders for their vote or approval, except only as the laws of the State of Delaware require that voting rights be granted to such nonvoting shares.
