**AMENDED AND RESTATED TRADEMARK SECURITY AGREEMENT**

**THIS AMENDED AND RESTATED TRADEMARK SECURITY AGREEMENT** (the “Agreement”) is made as of September 19, 2018, by Keeco Holdings, LLC, a limited liability company organized under the laws of the State of California with offices located at 30736 Wiegman Rd., Hayward, CA 94544 (“Holdings”), Keeco, LLC, a limited liability company organized under the laws of the State of California with offices located at 30736 Wiegman Rd., Hayward, CA 94544 (“Keeco”), Keeco Homestyles Corp., a corporation organized under the laws of the State of Delaware with offices located at 30736 Wiegman Rd., Hayward, CA 94544 (“MergerSub”), Ellery Homestyles Holding Corporation, a corporation organized under the laws of the State of Delaware with offices located at 295 Fifth Ave., Room 1212, New York, NY 10016 (“Ellery Holding”), and Ellery Holdings LLC, a limited liability company organized under the laws of the State of Delaware with offices located at 295 Fifth Ave., Room 1212, New York, NY 10016 (“Ellery”, together with Holdings, Keeco, MergerSub and Ellery Holding, the “Grantors”, and each a “Grantor”), in favor of **PNC BANK, NATIONAL ASSOCIATION** (“PNC”) as agent for the Lenders described below (in such capacity, “Agent”):

**W I T N E S S E T H**

**WHEREAS**, the Grantors, certain affiliates of the Grantors party thereto from time to time, the lenders party thereto from time to time (collectively, the “Lenders”) and Agent have entered into a certain Amended and Restated Revolving Credit and Security Agreement dated as of the date hereof (as the same may be amended, restated, amended and restated, supplemented and/or otherwise modified from time to time, the “Credit Agreement”), providing for extensions of credit to be made to the Borrowers thereunder by Agent and Lenders; and

**WHEREAS**, pursuant to the terms of the Credit Agreement, each Grantor has granted to Agent, for itself and the ratable benefit of Lenders, a security interest in substantially all of the assets of such Grantor;

**NOW, THEREFORE**, in consideration of the premises set forth herein and for other good and valuable consideration, receipt and sufficiency of which are hereby acknowledged, each Grantor agrees as follows:

1. **Defined Terms**. All terms capitalized but not otherwise defined herein shall have the same meanings herein as in the Credit Agreement.

2. **Grant and Reaffirmation of Grant of Security Interests**. To secure the complete and timely payment and satisfaction of the Obligations, each Grantor hereby grants to Agent, for itself and the ratable benefit of Lenders, and hereby reaffirms its prior grant pursuant to the Credit Agreement of, a continuing security interest in such Grantor's entire right, title and interest in and to the following, whether now owned or existing or hereafter created or acquired (collectively, the “Trademark Collateral”):

a) each trademark, trademark application and/or trademark registration listed on Schedule 1 annexed hereto, together with any renewals, continuations or extensions thereof, and all of the goodwill of the business connected with the use of, and symbolized by, such trademark, trademark application and/or trademark registration; and

b) all products and proceeds of the foregoing, including without limitation, any claim by such Grantor against third parties for past, present or future (i) infringement or dilution of any trademark, trademark application and/or trademark registration, or (ii) injury to the goodwill associated with any trademark, trademark application and/or trademark registration.

3. Credit Agreement. The security interests granted pursuant to this Agreement are granted in conjunction with the security interests granted to Agent, on behalf of itself and Lenders, pursuant to the Credit Agreement. Each Grantor hereby acknowledges and affirms that the rights and remedies of Agent with respect to the security interest in the Trademark Collateral made and granted hereby are more fully set forth in the Credit Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein.

4. Counterparts. This Agreement may be executed by the parties hereto in several counterparts, each of which shall be deemed to be an original and all of which shall constitute together but one and the same agreement. Delivery of an executed counterpart of a signature page to this Agreement by facsimile shall be effective as delivery of a manually executed counterpart of this Agreement.

5. CHOICE OF LAW AND VENUE; JURY TRIAL WAIVER; JUDICIAL REFERENCE. THIS AGREEMENT SHALL BE SUBJECT TO THE PROVISIONS REGARDING CHOICE OF LAW AND VENUE, JURY TRIAL WAIVER AND JUDICIAL REFERENCE SET FORTH IN SECTION 16.1 AND 12.3 OF THE CREDIT AGREEMENT, AND SUCH PROVISIONS ARE INCORPORATED HEREIN BY THIS REFERENCE, *MUTATIS MUTANDIS*.


6. NO NOVATION. Each Grantor hereby agrees that, effective upon the execution and delivery of this Agreement by each Grantor, the terms and provisions of the Trademark Security Agreement dated as of September 27, 2013 (the "Prior Trademark Security Agreement") shall be and hereby are amended, restated and superseded in their entirety by the terms and provisions of this Agreement. Nothing herein contained shall be construed as a substitution or novation of the obligations of any Grantor outstanding under the Prior Trademark Security Agreement, which obligations shall remain in full force and effect, except to the extent that the terms thereof are modified hereby or by instruments executed concurrently herewith. Nothing expressed or implied in this Agreement shall be construed as a release or other discharge of a Grantor from any of its obligations or liabilities under the Prior Trademark Security Agreement or any of the other loan documents executed in connection therewith. Each Grantor hereby confirms and agrees that each Loan Document to which it is a party is, and shall continue to be, in full force and effect and is hereby ratified and confirmed in all respects except that on and after the date hereof all references in any such Loan Document to "the Trademark Security Agreement", "thereto", "thereof", "thereunder" or words of like import referring to the Prior Trademark Security Agreement shall mean the Prior Trademark Security Agreement as amended and restated by this Agreement.

7. INTERCREDITOR AGREEMENT. Notwithstanding anything herein to the contrary, the Lien granted to Agent pursuant to this Agreement and the exercise of any right or remedy by Agent hereunder are subject to the provisions of the Intercreditor Agreement. In the event of any conflict between the terms of the Intercreditor Agreement and the terms of this Agreement, the terms of the Intercreditor Agreement shall govern and control.






