RELEASE OF SECURITY AND PLEDGE AGREEMENT

This Release of Security and Pledge Agreement ("Release") is made effective as of October 17, 2018 by CM AGENCY, LLC, in its capacity as administrative agent (the "Administrative Agent") for the holders of the Secured Obligations referenced in that certain Security and Pledge Agreement dated as of September 29, 2017 (as the same may be amended, modified, restated or supplemented from time to time, the "Agreement") by and among the Obligor from time to time party thereto (each an "Obligor" and collectively, the "Obligors") and the Administrative Agent, as follows:

WHEREAS, pursuant to the Agreement, the Obligors set forth on Schedule 1 attached hereto granted to the Administrative Agent a continuing security interest in any and all right, title and interest of such Obligors in and to the (a) patents and patent applications, (b) trademarks and trademark applications and (c) copyrights and copyright applications shown on Schedule 2 attached hereto, whether now owned or existing or owned, acquired, or arising hereafter (collectively, the "Security Agreement Collateral");

WHEREAS, a Notice of Grant of Security Interest in Intellectual Property was recorded in the United States Patent and Trademark Office on October 16, 2017 at Reel 044212 / Frame 0957 (Patents) and on October 16, 2017 at Reel 6182 / Frame 0989 (Trademarks);

WHEREAS, a Notice of Grant of Security Interest in Intellectual Property was recorded in the United States Copyright Office on October 25, 2017 at V9951D293.

WHEREAS, the Administrative Agent wishes to release its security interest in the Security Agreement Collateral.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby agrees as follows:

1. Release. The Administrative Agent hereby, without warranty as to status of title or priority of the encumbrances being hereby released, releases, discharges, terminates and cancels all right, title and interest in, to and under the Security Agreement Collateral, including, without limitation, any security interest it may have in the Security Agreement Collateral and the goodwill of the business connected with the use of, and symbolized by, the Security Agreement Collateral, and retransfers and reassigns any and all right, title, and interest it may have in the foregoing without recourse solely as to the Obligors.

2. Further Assurances. At the request and expense of the Obligors, the Administrative Agent hereby agrees to perform all other and further acts, and provide to the Obligors and their successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Obligors to retransfer and reassign any and all right, title and interest it may have in the Security Agreement Collateral without recourse to the Obligors.

IN WITNESS WHEREOF, the Administrative Agent has caused this Release to be executed by its duly authorized officer.
