RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”) is made as of October 22, 2018 (“Effective Date”) by and between **WELLS FARGO BANK, NATIONAL ASSOCIATION**, a national banking association (“Grantee”), and **PRETZELS, LLC**, a Delaware limited liability company (formerly known as Pretzels, Inc., an Indiana corporation), (“Grantor”).

WHEREAS, pursuant to the terms and conditions of that certain Trademark Security Agreement by and between Grantor and Grantee dated March 23, 2017 (the “Trademark Security Agreement”), Grantor granted to Grantee a continuing security interest in and to all of Grantor’s right, title and interest in and to all of the trademarks, and registrations of and applications to register the foregoing, and all of the trade names and assumed names owned by Grantor (collectively, the “Trademarks”), including, without limitation, the United States trademark registrations set forth on Schedule A attached hereto and the United States application for trademark registration set forth on Schedule B attached hereto, in each case, together with the goodwill associated therewith;

WHEREAS, Grantor and Grantee entered into the Trademark Security Agreement pursuant to the terms and conditions of that certain Credit Agreement by and among Grantor, Pretzels Plymouth, LLC, and Grantee dated March 23, 2017 (the “Credit Agreement”);

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office (“PTO”) on March 27, 2017, at Reel 6019, Frame 0980; and

WHEREAS, Grantor has paid all of its outstanding indebtedness to Grantee.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantee hereby terminates the Trademark Security Agreement, and hereby terminates, cancels and releases any and all security interests it has against the Trademarks and the other Trademark Collateral (as defined in the Trademark Security Agreement).

Grantee shall take all further actions, and provide to Grantor, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments) reasonably requested by Grantor to more fully and effectively effectuate the purposes of this Release.
