## RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS dated as of September 25, 2018 (this "Release") is made by Comerica Bank, as agent (the "Secured Party") under that certain Second Amended and Restated Revolving Credit and Term Loan Agreement (as amended, restated or otherwise modified from time to time, the "Credit Agreement") dated March 7, 2017, by and among Penske Business Media, LLC, a Delaware limited liability company ("Borrower"), and Comerica Bank and the other lenders from time to time signatory thereto (each, individually, a "Bank" and collectively, the "Banks") and Secured Party.

WHEREAS, pursuant to the Security Agreements, Debtors granted to the Secured Party security interests in the Debtors' trademarks, including the trademarks listed on the attached Exhibit A (collectively, the "Trademarks").

WHEREAS, the Secured Party wishes to: (i) release and terminate all of its security interest covering the Trademarks; (ii) restore all right, title and interest in and to the Trademarks to the applicable Debtor; and (iii) terminate any and all liens and encumbrances respecting the Trademarks under the Security Agreements.


