RELEASE OF TRADEMARKS

THIS RELEASE OF TRADEMARKS is made as of the 12th day of October, 2018, by FIRST NATIONAL BANK OF PENNSYLVANIA, a national banking association ("LENDER"), with its mailing address at 1000 Bestgate Road, Annapolis, Maryland 21401, in favor of DATUM LLC, a Virginia limited liability company ("ASSIGNOR") with its mailing address at One Park Place, Suite 540, Annapolis, Maryland 21401.

RECITALS

Pursuant to the terms of a Trademark Security Agreement dated as of March 19, 2018 by ASSIGNOR in favor of the LENDER and recorded on March 20, 2018 with the United States Patent & Trademark Office in Reel 6294, Frame 913 (#900443387) ("TRADEMARK AGREEMENT"), ASSIGNOR granted to the LENDER a security interest in, to and against all of the ASSIGNOR'S domain names, service marks, trademarks (including, without limitation, Trademark Registration Nos. 4244521 and 5309772) whether registered or unregistered, and whether or not established or registered in the United States or any other country or any political subdivisions thereof, together with any and all: (a) registrations and recordings thereof, and all applications for any of the foregoing, including, without limitation, registrations recordings and applications in the United States Patent and Trademark Office or any other country or political subdivision, (b) all renewals, reissues, confirmations and extensions thereof, (c) all intellectual property of the ASSIGNOR and goodwill of the ASSIGNOR'S business to which any of the foregoing relates, (d) all present and future claims, causes of action and rights to sue for past, present or future infringements thereof, (e) all rights and privileges arising under applicable law with respect to the use of any of the foregoing, (f) all general intangibles, proceeds and products related to any of the foregoing and (g) all rights corresponding thereto throughout the world ("TRADEMARKS").

The LENDER has agreed to release all of its right, title, and interest in and to the TRADEMARKS.

NOW, THEREFORE, in consideration of the premises, and other good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, the LENDER agrees as follows:




