RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release") is made as of October 24, 2018, by ROYAL BANK OF CANADA (the "Administrative Agent"), in favor of ZEDI CANADA INC. (the "Grantor").

WHEREAS, pursuant to that certain Credit Agreement dated February 20, 2014 by and among the Grantor, as borrower, certain affiliates of the Grantor from time to time party thereto, as borrowers, certain financial institutions from time to time party thereto (the "Secured Lenders"), and Administrative Agent, in its capacity as administrative agent for and on behalf of each Secured Lender (as amended, restated, supplemented, or otherwise modified from time to time, the "Credit Agreement"), the Administrative Agent and Secured Lenders made certain financial accommodations to the Grantor;

WHEREAS, pursuant to that certain Trademark Security Agreement dated as of February 20, 2014 (as amended, supplemented or otherwise modified from time to time, the "Trademark Security Agreement") and recorded with the U.S. Patent and Trademark Office on Reel/Frame No. 005283/0310 by and between the Grantor and the Administrative Agent, the Grantor granted the Administrative Agent a security interest in, among other things, the trademark registrations and trademark applications listed on Exhibit A attached hereto, any goodwill of the business connected with the use thereof and symbolized thereby and any proceeds derived therefrom or in connection therewith (collectively, the "Trademarks"), and pledged (but did not transfer title to) the Trademarks to the Administrative Agent; and

WHEREAS, as of the date hereof, all obligations of the Grantor owing to the Administrative Agent under the Credit Agreement have been satisfied, and the Grantor has requested the Administrative Agent release its security interest in the Patents in accordance with this Release.

NOW, THEREFORE, for valuable consideration:

The Administrative Agent hereby terminates and releases its security interest in the Trademarks, and the Administrative Agent hereby assigns and transfers to the Grantor as identified on Exhibit A, without any representation, warranty, or recourse whatsoever, the Administrative Agent's entire right, title, and interest in and to the Trademarks, effective as of the date set forth above.

The Administrative Agent hereby agrees to execute such further instruments and documents and perform such further acts as the Grantor may deem necessary to convey to the Grantor the rights herein conveyed.


