This Notice of Grant of Security Interest in Trademarks and Patents is being entered into as of October 4, 2018 by Purch Group, LLC, a Delaware limited liability company ("Purch") in favor of HSBC UK Bank Plc (formerly known as HSBC Bank plc) (the "Secured Party"). Pursuant to the Second Amended and Restated Security Agreement, dated as of April 3, 2018 (as amended, modified, extended, restated, renewed, replaced, or supplemented from time to time, the "Agreement") among Purch, the other Grantors party thereto (each, including, without limitation, Purch, a "Grantor" and collectively, the "Grantors") and Secured Party, Purch has granted a continuing security interest in and continuing lien upon all of its right, title and interest in, to and under the following (collectively, the "Intellectual Property Collateral"):

(a) all United States, and foreign trademarks, trade names, corporate names, company names, business names, fictitious business names, Internet domain names, service marks, certification marks, collective marks, logos, other source or business identifiers, designs and general intangibles of a like nature, all registrations and applications for any of the foregoing including, but not limited to (i) the registrations and applications referred to in Annex 1 attached hereto, (ii) all extensions or renewals of any of the foregoing, (iii) all of the goodwill of the business associated with the use of and symbolized by the foregoing, (iv) the right to sue for past, present and future infringement or dilution of any of the foregoing or for any injury to goodwill, and (v) all proceeds of the foregoing, including licenses, royalties, income, payments, claims, damages, and proceeds of suit; and


(b) all United States and foreign patents and certificates of invention, or similar industrial property, design or plant rights, for any of the foregoing, including, but not limited to: (i) all registrations, provisional patents and applications referred to in Annex 2 attached hereto; (ii) all reissues, divisions, continuations, continuations-in-part, extensions, renewals, and reexaminations therefor; (iii) all rights corresponding thereto throughout the world; (iv) all inventions and improvements described therein; (v) all rights to sue for past, present and future infringements thereof; (vi) all licenses, claims, damages, and proceeds of suit arising therefrom; and (vii) all proceeds of the foregoing, including licenses, royalties, income, payments, claims, damages, and proceeds of suit.

Purch hereby acknowledges and agrees that the security interest in the foregoing Intellectual Property Collateral (a) may only be terminated in accordance with the terms of the Agreement and (b) is not to be construed as an assignment of any Intellectual Property Collateral.




