## TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of October 9, 2018 (“Release”), is made by Bank of America, N.A., as Administrative Agent (“Administrative Agent”) in favor of Syntel, Inc., a Michigan corporation (“Obligor”).

**WHEREAS**, pursuant to that certain Security and Pledge Agreement dated as of September 12, 2016 by and among the Obligor, Administrative Agent, and other parties thereto (as amended, restated, supplemented, modified, extended, renewed or replaced from time to time, the “Security Agreement”), Obligor granted to the Administrative Agent, for the benefit of the holders of the Secured Obligations (“Secured Parties”), a continuing security interest in any and all right, title and interest of Obligor (and any applicable assignee thereof) in and to all then-owned or existing, or thereafter owned, acquired, or arising, General Intangibles, Trademarks, Trademark Licenses, Accessions, and Proceeds of all of the foregoing (collectively, “Trademark Collateral”); and

**WHEREAS**, pursuant to the Security Agreement, Obligor executed and delivered to Administrative Agent, for the benefit of the Secured Parties, the Notice of Grant of Security Interest in Trademarks recorded at the United States Patent and Trademark Office (“USPTO”) on November 2, 2016 at Reel 5915 Frame 0051 (“Notice”).

**NOW THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Administrative Agent, on behalf of the Secured Parties, and Obligor agree as follows:

**SECTION 1. Defined Terms.** All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement or Notice.

**SECTION 2. Termination and Release.** Administrative Agent, on behalf of the Secured Parties, without representation, warranty, or recourse, hereby:

(a) terminates, cancels, discharges, and releases fully the entirety of Administrative Agent’s security interest in Obligor’s (and any applicable assignee’s) right, title, and interest in and to all the Trademark Collateral, including, but not limited to, the foregoing listed on Schedule A attached hereto, granted pursuant to the Security Agreement or Notice; and

(b) authorizes the recordation of this Release by Obligor (or any applicable assignee thereof) or Obligor’s (or such assignee’s) authorized representative with the USPTO and any similar office or agency of the United States, any state thereof, any other country or any political subdivision thereof, and any applicable office or agency thereof at Obligor’s expense.

**SECTION 3. Choice of Law; General.** This Release shall be governed by and construed in accordance with the laws of the State of New York, without regard to conflicts of law principles. This Release may be executed in counterparts, each of which when executed will be deemed to be an original but all of which taken together will constitute one and the same agreement. The words “include”, “including” and variations thereof will be deemed to be followed by the words “without limitation”. The use of “or” will not be deemed to be exclusive. If any provision of this Release is, for any reason, held to be invalid or unenforceable, the other provisions of this Release will be unimpaired and the invalid or unenforceable provision will be deemed modified so that it is valid and enforceable to the maximum extent permitted by law.

**IN WITNESS WHEREOF**, the Administrative Agent, on behalf of the Secured Parties, and Obligor have caused this Termination and Release of Security Interest in Trademarks to be duly executed as of the date first set forth above.


