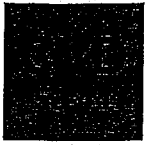

## ARTICLES OF ORGANIZATION

OF

### INTOUCH GROUP, LLC

---

The undersigned, in order to form a limited liability company for the purposes hereinafter stated under and pursuant to the Kansas Limited Liability Company Act (the "Act"), and in compliance with the Plan of Conversion of Intouch Solutions, Inc., hereby agrees and certifies as follows.

#### ARTICLE I NAME

The name of the limited liability company formed hereby (the "Company") is **INTOUCH GROUP, LLC**.

#### ARTICLE II DURATION

The existence of the Company shall be perpetual, provided, however, that the Company shall be dissolved upon the earlier of the written agreement of the Company Members (the "Members"), or the occurrence of any other event set forth in the Act which causes the dissolution of the Company and, if applicable, subject to the provisions of Article VI below.

#### ARTICLE III PURPOSE

The Company is organized for profit to engage in any act or activity for which limited liability companies may be organized under the Act, as now in effect and as may hereafter be amended.

#### ARTICLE IV REGISTERED OFFICE AND REGISTERED AGENT

The address of the Company's initial registered office in the State of Kansas is 7225 Renner Road, Suite 200, Shawnee, Johnson County, KS 66217. The name of its initial resident agent at such address is Thomas M. Mullinix. The Company is authorized and empowered to transact and engage in business in any and all other states, territories and countries, without limitation, both within and without the United States of America.

#### ARTICLE V ADDITIONAL MEMBERS AND TRANSFER OF A MEMBERSHIP INTEREST

Admission of additional Members to the Company and the transferability of a Member's interest in the Company shall be governed by the Act and the Operating Agreement of the Company.

ARTICLE VI  
DISSOLUTION AND THE RIGHT TO CONTINUE  
BUSINESS OF THE COMPANY

Subject to the Members' right to continue the business of the Company, upon the occurrence of any event, which results in the dissolution of the Company, the Company shall be dissolved. If dissolution of the Company is caused by the death, retirement, resignation, expulsion, bankruptcy or dissolution of a Member or any other event, which terminates a Member's continued membership in the Company, the business of the Company may be continued by the remaining Members. Dissolution of the Company and the right to continue the business of the Company shall be governed by the Act.

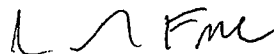
