RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”), dated as of September 28, 2018, is made by and between **OAKTREE FUND ADMINISTRATION, LLC** (as successor to Fifth Street Management LLC), as agent (“Agent”), and **VALET LIVING, LLC (f/k/a Valet Waste, LLC)** (the “Grantor”), a Delaware limited liability company.

RECITALS:

WHEREAS, Grantor and Fifth Street Management LLC (“Resigning Agent”) are parties to that certain Guaranty and Collateral Agreement, dated as of September 24, 2015 (as the same has been and may thereafter be amended, restated, supplemented or otherwise modified from time to time, the “Security Agreement”), pursuant to which Grantor entered into that certain Trademark Security Agreement, dated as of September 24, 2015 (the “Trademark Security Agreement”) and granted to Resigning Agent a security interest in all of its right, title and interest in, to and under certain Trademark Collateral (as defined below);

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on September 24, 2015, at Reel/Frame: 5629/0460;

WHEREAS, Resigning Agent and Agent entered into that certain Assignment of Trademark Security Agreement (the “Assignment Agreement”), effective as of October 17, 2017, pursuant to which Resigning Agent assigned and transferred to Agent and its successors and assigns, all of its rights, title and interest in and to the Trademark Security Agreement and the Trademark Collateral;

WHEREAS, the Assignment Agreement was recorded with the United States Patent and Trademark Office on October 20, 2017, at Reel/Frame: 6188/0745;

WHEREAS, Grantor has requested and Agent has agreed to release its rights and security interests in the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Agent hereby agrees as follows:

1. Defined Terms. All capitalized terms used herein but not otherwise defined have the meanings set forth in the Security Agreement.

2. Release of Security Interest. Agent hereby fully and finally terminates the Trademark Security Agreement and releases, without any representation, its security interest and rights in, to and under the following (collectively, the “Trademark Collateral”):

(a) all of the Grantor’s Trademarks to which it is a party, including those referred to on Schedule A.

3. Authorization. Agent hereby authorizes Grantor or Grantor’s agent to record this Release with the United States Patent and Trademark Office.
