## TRADEMARK ASSIGNMENT

This Trademark Assignment ("Assignment"), effective as of February 22, 2018, is by and between Gibson Brands, Inc., a Delaware corporation, with an address of 309 Plus Park Blvd., Nashville TN 37217 (hereinafter "Assignor"), and BandLab, a Cayman Islands company, with a registered office at PO Box 309, Ugland House, Grand Cayman KY1-1104, (hereinafter "Assignee").

WHEREAS, Assignor is the sole and exclusive owner of the trademarks set forth in Schedule A attached hereto and incorporated herewith, together with all other rights appurtenant thereto, including, but not limited to, common law rights, title and interest, trade name rights, and the right to recover for past infringement, in the United States of America and all other countries and jurisdictions of the world, and any applications and registrations thereof, including, but not limited to, any intent-to-use applications (hereinafter collectively referred to as the "Trademarks");

WHEREAS, Assignor is assigning the Trademarks and all applications and registrations therefor as part of the entire business or portion thereof to which the marks pertain as required by 15 U.S.C. §1060.

WHEREAS, Assignee desires to acquire all rights, title and interest in and to the Trademarks worldwide; and

WHEREAS, Assignor desires to assign to Assignee all rights, title and interest as Assignor may possess in and to the Trademarks worldwide.

NOW THEREFORE, for good and adequate consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby sells, transfers, conveys and assigns to Assignee, its successors, assigns and other legal representatives, all right, title and interest as Assignor may possess in and to the Trademarks worldwide, together with (i) the goodwill symbolized by said Trademarks, (ii) the business or portion of the business to which the Trademarks pertain, (iii) all registrations and applications (including intent-to-use applications, and any extensions and renewals of any registrations and applications) for the Trademarks, (iv) all income, royalties, damages (including attorneys' fees) and payments in respect of the Trademarks, and (v) all claims that could be asserted by Assignor arising out of or relating to the use or ownership of the Trademarks, including without limitation all claims, demands, causes of action (either in law or in equity) and the right to sue, counterclaim and recover for infringement of the Trademarks (whether arising prior to or subsequent to the date of this Assignment), in all cases for the use and enjoyment of Assignee, its successors, assigns and other legal representatives.

To the extent applicable, Assignor authorizes and requests the Commissioner for Trademarks and the empowered officials of all other governments to record this Assignment and Assignee as owner of the Trademarks, for the sole use and enjoyment of Assignee, its successors, assigns or other legal representatives.


Assignor shall take all further actions, and provide to Assignee, Assignee's successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all affidavits, declarations, oaths, samples, exhibits, specimens, assignments, powers of attorney or other documentation), requested by Assignee to more fully and effectively effectuate the purposes of this Assignment, including, without limitation, with respect to the following: (1) the preparation and prosecution of any application for registration, or any application for renewal of a registration, relating to any of the rights assigned herein; (2) the prosecution or defense of any cancelation, interference, opposition, infringement or other proceedings that may arise in connection with any of the rights assigned herein, including, without limitation, testifying as to any facts relating to the Trademark and this Assignment; (3) obtaining any additional protection (patent or otherwise) relating to rights assigned herein that Assignee reasonably may deem appropriate that may be secured under the laws now or hereafter in effect in the United States or in any foreign country; and (4) in the implementation or perfection of this Assignment in all applicable jurisdictions throughout the world. Assignor hereby appoints the person who is from time to time Assignee's president as Assignor's agent and attorney-in-fact to execute all documents on behalf of Assignor and its employees for this limited purpose. Assignor acknowledges that the grant of the foregoing power of attorney is coupled with an interest and shall survive the dissolution or termination of Assignor.
