WHEREAS, Assignor is the owner of the common law and registered trademarks as detailed in Exhibit A, (collectively hereinafter, the "Marks").



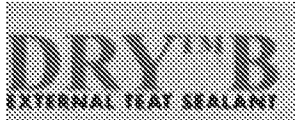

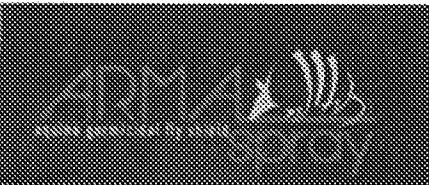
